São Paulo, March 7, 2018 - GOL Linhas Aéreas Inteligentes S.A. (“GOL” or “Company”), (NYSE: GOL and B3: GOLL4), Brazil’s #1 airline, today provides general outlook and guidance for full year 2019 (preliminary).

The Company’s guidance highlights key metrics which impact financial results and drive long-term shareholder value.
